ORGANIZATION OVERVIEW

MISSION

We are an organization of performance ensembles creating a diverse and inclusive environment for musical expression that promotes the equity and visibility of people in the LGBTQIA+ community.

CORE VALUES

- Increasing visibility of LGBTQIA+ people
- Focusing on diversity and equity in what we choose to perform
- Strengthening equity and inclusion for our members and patrons to experience music



HISTORY

Rainbow City Performing Arts (RCPA) was founded in 1998 to create a safe and accepting space for LGBTQIA+ musicians to participate in Seattle's vibrant community music scene. Initially established as Rainbow City Band, the organization has since expanded to include seven diverse performance ensembles, incorporating instrumental, visual, and partnered vocal performances.

RECENT ACHIEVEMENTS

In the past two years, RCPA has experienced significant growth and success:

- **Membership Growth:** Our membership has increased by over 100%, reflecting our expanding reach and the strong sense of community we foster. Demand to expand programs continues.
- **Successful Events:** We have hosted numerous high-profile events, such as our Benaroya concerts and various community performances, which have significantly raised our profile and engaged a broader audience.
- **Grant Awards:** We have secured several grants from local and national foundations, enabling us to enhance our programs and services. These grants have supported initiatives like our Amplifying Diverse Voices annual commission project, which funds the creation of new works by marginalized artists.

PROGRAM REVIEW



MARCHING BAND

This ensemble brings music to the masses each summer, participating in parades and festivals throughout the Northwest. The band is known for its vibrant performances and strong community presence.



DRUMLINE

Rainbow City Drumline supports both the marching band and pep bands throughout their seasons. Known for their energetic performances, the drumline adds a dynamic element to every performance. They also offer drum skills workshops during the offseason.



COLOR GUARD

Our guard is the visual arm of the marching unit, bringing excitement and pizzazz to parade and festival appearances. They perform intricate routines with flags, air blades, and sabers. They also host skills workshops and Winterguard throughout the rest of the season.



CONCERT BAND

Our largest ensemble delights audiences with classical and contemporary music for winds. Performing at concerts in the fall, winter, and spring, this ensemble showcases a wide range of musical styles and provides members with opportunities to develop their skills.



PEP BAND

Reign City Riot is the official pep band of the Seattle Reign women's soccer team. This ensemble energizes sports and community events with lively performances, creating an engaging and spirited atmosphere.



JAZZ BAND

Our jazz band and jazz combo bring a variety of lively jazz tunes to concerts, dances, and other events around the Puget Sound area. This ensemble provides a platform for musicians to explore diverse jazz music.



ORCHESTRA

Rainbow City Orchestra is dedicated to queering the sense of what it means to be an orchestra and perform music that relates to the LGBTQIA+ community. They perform a wide range of classical and contemporary music, often highlighting compositions by marginalized artists.



CHAMBER MUSIC

Our chamber ensembles are organized by members to offer flexibility and belonging, allowing musicians to explore a variety of musical styles and perform in more intimate settings.

COMMUNITY IMPACT

RCPA's commitment to inclusivity and excellence has made a meaningful impact on the community:

- Safe Space for Musicians:** We provide a safe and supportive environment for LGBTQIA+ musicians who may have faced rejection or discomfort in other musical outlets. Our members form strong bonds through shared experiences and a common mission.
- Accessible Opportunities:** We direct much of our charity work towards youth-focused organizations and all-ages events, ensuring that our programs are accessible to people of all ages and abilities. Our member-funded Angel Fund allows those with income challenges to participate for free, and we provide instruments at no charge to those in need.
- Promoting Equity and Visibility:** Our performances intentionally focus on music composed or arranged by artists of marginalized identities and highlight themes relevant to the LGBTQIA+ community. Through our efforts, we promote equity and visibility for LGBTQIA+ individuals, advocating for a more inclusive and just society.





APPLICATION PROCESS

We are thrilled that you are considering joining our board! The application process is designed to ensure that prospective board members are well-prepared and aligned with our mission of celebrating LGBTQIA+ diversity and inclusion through musical expression.

To begin, express your interest by reaching out via [our website](#) or connecting with a current board member or our Executive Director. You will then receive an information packet detailing our organization and the roles of our board members.

Next, you will need to complete and submit an application form. Our committee will review your application, and selected candidates will be invited for a preliminary interview.

If you move forward, you will participate in an in-depth interview with the full selection committee. This is also an opportunity for you to ask any questions you may have about the organization and the board.

Following the interviews, the board will deliberate and vote on the candidates. If selected, you will be formally approved and welcomed to the team.
